A RESOLUTION OF THE FRESNO LOCAL AGENCY FORMATION COMMISSION MAKING
DETERMINATIONS AND ADOPTING A MUNICIPAL SERVICE REVIEW; MAKING
DETERMINATIONS AND UPDATING THE FIG GARDEN FIRE PROTECTION DISTRICT
SPHERE OF INFLUENCE

WHEREAS, pursuant to the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000 (Government Code Section 56425 *et seq.*) the Fresno Local Agency Formation Commission is required to review and update, as necessary, spheres of influence (SOI) of local agencies; and

WHEREAS, Government Code Section 56430 directs the Commission to conduct a review of municipal services not later than the time it considers an action to establish or update a SOI in accordance with Section 56425; and

WHEREAS, the Executive Officer prepared a Municipal Service Review (MSR) and SOI update for the Fig Garden Fire Protection District (District); and

WHEREAS, notice of the Commission's hearing of said MSR was duly given in a publication of general circulation as required by the Cortese-Knox-Hertzberg Local Government Reorganization Act of 2000, and at the time and in the form and manner provided by law; and

WHEREAS, at the public meeting, held on February 8, 2017, the Commission considered all relevant evidence including, but not limited to, the MSR and related SOI analysis, draft determinations therein, environmental documentation, and all testimony, correspondence, and exhibits received during the public hearing process, all of which are included herein by reference.

NOW, THEREFORE, BE IT RESOLVED that the Fresno Local Agency Formation Commission does HEREBY DETERMINE AND ORDER, as follows:

Section No. 1. Acting as Lead Agency pursuant to California Environmental Quality Act (CEQA) Guidelines the Commission finds that the MSR prepared for the Fig Garden Fire Protection District is Categorically Exempt from the provisions of CEQA under Section 15306, "Information Collection."

Section No. 2. This Commission finds that the MSR prepared for Fig Garden Fire

Section No. 3. This Commission finds that the written determinations within the MSR and Sphere of Influence update for Fig Garden Fire Protection District satisfy State law.

Section No. 4. Pursuant to Government Code Sections 56425 and 56430, this Commission makes the required determinations for the MSR and SOI update, adopts the Municipal Service Review prepared for Fig Garden Fire Protection District, and updates the sphere of influence for the District by reaffirming its boundaries (Attachment A).



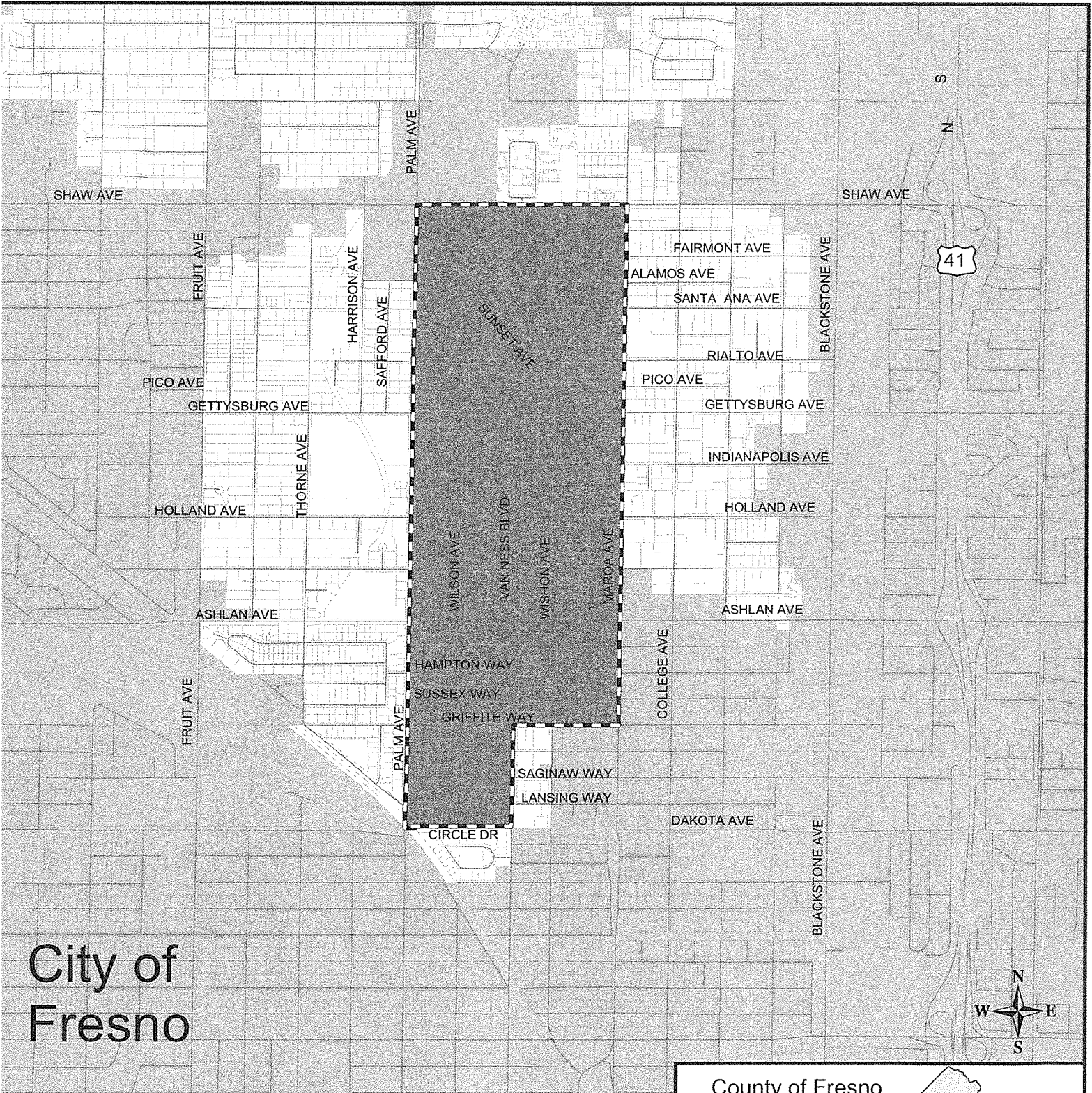
